I am so excited to welcome you to the Shine-a-Light Task Force. This Task Force is an extension of the Daytona Dream Center; and was formed specifically to raise awareness, spread education, and provide resources for the restoration of survivors of human trafficking. Before I delve into the Task Force itself, I'd like to take a moment and explain the heart and vision of the Daytona Dream Center.

The Daytona Dream Center was established in 2018, and its heartbeat is to see the community transformed by the powerful love of God. The aim is to create a healthy and flourishing community, by providing opportunities and personal development to individuals in need. The Daytona Dream Center strives to link arms with local partners to unlock our full potential, as well as, invest in those who call Daytona home.

The Shine-A-Light Task Force is faith based, and we are committed to bringing an end to human trafficking in Daytona Beach, and beyond. It is estimated that there are 40.3 million victims of human trafficking globally. 81% are trapped in forced labor, 25% are children, and 75% are women and girls. Although there is no official estimate of the total number of human trafficking victims, U.S. Polaris estimates that the total victim count reaches into the hundreds of thousands, right here in America.

Human Trafficking isn't just happening in other countries across the world, but it's happening right here in Daytona Beach, in our own backyards. To our neighbors, our children, our restaurant servers, and hotel workers. It's modern day slavery, and the Shine-A-Light Task Force is on a mission to end it.

Thank you for joining this force. I'm eager to see how God uses your individual giftings and abilities within Shine-A-Light. We don't believe it's by accident or coincidence that you're here, and know God has a plan to use YOU to help end human trafficking.

This binder has information about our teams, we ask that you go over each area, and prayerfully consider which area(s) you would fit well in, based on your giftings and passions. Mission: Daytona Dream Center has formed the Shine-A-Light task force to spread awareness, education, and provide resources for the restoration of survivors of human trafficking in our community. The DDC is a community minded, faith-based, outreach driven organization that strives to link arms with others to help bring an end to human trafficking in Daytona Beach and beyond.

Teams:

- **Street Teams:**
 - Organize prayer teams; partner with churches, organizations etc.
 - Pray
 - Educate people to recognize the warning signs of exploitation & abuse
 - Report suspicious activity
 - Lead hotel and juvenile detention center organized outreaches

- **General Awareness:**
 - Community: Host an awareness event; bring together community leaders and concerned citizens, stats of HT for this area and what we can do about it.
 - What is happening, how it's happening & what we can do to end it.
 - Plan and organize
 - Speak
 - Provide training, education, and resource information
 - Create partnership opportunities
 - Attend the government anti-sex trafficking lobby day etc.
 - Stay current with local news and undercover information released on arrests and local operations
 - Social Media
 - Establish our niche within the faith-based community.
 - Outreach
 - Training
 - Partnerships
 - Conduct training on how to recognize the warning signs of exploitation & abuse
 - Gather solid speakers, statistics, resources, and information on how to get involved
 - Educate people on reporting suspicious activity
 - Create training programs for partners: faith, business, schools etc.
 - Youth Initiatives, faith, schools, student clubs
 - Faith community: Staff, congregation, and youth
 - Business: Educate staff, how to recognize and report activity etc.
 - Government: Create awareness, get education on HT laws

- **Youth Initiatives & Curriculum:**
 - Educate and equip 5th – 12th grade youth
 - sex trafficking, pornography, internet and phone safety, safe boundaries and what to do if you suspect a friend is in trouble
 - Partner with churches, schools, community organizations, clubs
 - Provide resources on how to recognize red flags and report activity
 - How to engage on social media safely

- **Rescue:**
 - Initial 24/48 hours of the rescue
 - Available to take incoming inquiries
 - Meet local law enforcement
 - Stay with the survivor while a safe house is being secured
 - Take them shopping etc.
 - Be a part of the transportation, Uber process if needed

- **Prayer:**
 - Communicate rescue information to team for prayer
 - Organize monthly focused prayers
 - Create a prayer text message group

- **Donations & Fundraising:**
 - **Raise money to fight human trafficking**
 - Share impact updates to keep people engaged

 - Gather donations of personal hygiene items, backpacks, etc.

HIPAA CONFIDENTIALITY AGREEMENT

I acknowledge that during the course of performing my assigned duties at THE DAYTONA DREAM CENTER, as an employee/intern/volunteer I may have access to, use, or disclose confidential information.

I hereby agree to handle such information in a confidential manner at all times during and after my employment/internship/volunteer status and commit to the following obligations:

- A. I will use and disclose confidential information only in connection with and for the purpose of performing my assigned duties.
- B. I will request, obtain or communicate confidential information only as necessary to perform my assigned duties and shall refrain from requesting, obtaining or communicating more confidential information than is absolutely necessary to accomplish my assigned duties.
- C. I will take reasonable care to properly secure confidential information on my computer and will take steps to ensure that others cannot view or access such information. When I am away from my workstation or when my tasks are completed, I will log off my computer or use a password-protected screensaver in order to prevent access by unauthorized users.
- D. I will not disclose my personal password(s) to anyone without the express written permission of my department head or record or post it in an accessible location and will refrain from performing any tasks using another's password

I understand that as an employee/intern/volunteer of THE DREAM CENTER that the use and disclosure of client information is governed by the rules and regulations established under HIPAA, the Health Insurance Portability and Accountability Act of 1996, and related policies and procedures of THE DREAM CENTER.
